SIXTH AMENDMENT

TO

JOINT POWERS AGREEMENT

THIS SIXTH AMENDMENT TO JOINT POWERS AGREEMENT is made effective the 1st day of January, 2007, by and between BLAINE COUNTY, a political subdivision of the State of Idaho (the "County"), and the CITY OF HAILEY, an Idaho municipal corporation located within the County (the "City").

RECITALS:

On the 16th day of May, 1994, the City and County entered into a Joint Powers Agreement which created the Friedman Memorial Airport Authority (the "Agreement").

On the 27th day of March, 1996, the City and County entered into an Amendment to Joint Powers Agreement.

On the 8th day of July, 1996, the City and County entered into a Second Amendment to Joint Powers Agreement.

On the 7th day of October, 1998, the City and County entered into a Third Amendment to Joint Powers Agreement.

On the 5th day of June, 2000, the City and County entered into a Fourth Amendment to Joint Powers Agreement.

On the 29th day of August, 2006, the City and County entered into another Fourth Amendment to Joint Powers Agreement which was mistakenly designated.

On the 5th day of September, 2006, the City and County entered into a Fifth Amendment to Joint Powers Agreement.

The Agreement terminates on December 31, 2006, and the City and County believe an

extension of the term would be to the benefit of the citizens of the City and the County and the users of the Airport.

NOW, THEREFORE, the City and County do hereby agree that the Joint Powers Agreement shall be hereby amended to read as follows:

ARTICLE II

DURATION, AMENDMENT AND TERMINATION

Section 2.1: DURATION

The term of this Agreement shall commence on June 1, 1994 and terminate on December 31, 2011. Commencing on January 1, 2012, this Agreement shall be automatically extended for one year terms, unless either party hereto gives the other party written notice at least 60 days prior to the expiration of the then current term of its intent to terminate this Agreement on December 31st of the then current term.

All of the other terms and conditions of said JOINT POWERS AGREEMENT and the amendments thereto shall remain in full force and effect.
